Alcorn Family

The Alcorn family came to America prior to 1680. The earliest records found are of a John Alcorn, who immigrated to Philadelphia, PA, from Ulster, Ireland. The next record that we find is a deed dated Feb. 10, 1727, in Lancaster, PA, to James Alcorn. We next find James Alcorn, son of the above James Alcorn, in Augusta and Montgomery counties of Virginia. John Alcorn, son of the second James, came to Kentucky prior to 1793. Madison Co., KY, records show John Alcorn in 1793 giving Robert Breckenridge power of attorney to sell land in Wythe Co., VA.

Robert Alcorn, son of John and Jane Brechenridge Alcorn, was born between 1765-1775. Robert Alcorn married Susannah Turpin Welch, a widow, in Madison County.

John Alcorn, son of Robert and Susannah Welch Alcorn, was born 1799-1801. Jessamine Co. records show John Alcorn on the 1831 tax list. John Alcorn was married three times. He was a farmer and retail merchant.

This John Alcorn was not the first Alcorn in Jessamine Co., his second cousins, George and Robert Alcorn, were on the 1800 Jessamine County tax list. They remained on the Jessamine County tax list until 1806. They then moved to Clay County. George Alcorn was a Revolutionary War soldier and is listed in the "Jessamine County 175th Anniversary Souvenir Book." George Alcorn died in Bartholemeou Co., IN, in 1833. Robert, his brother, died in Pike County, IL, in 1831.

James Alcorn, son of John and his first wife, was born in 1832 in Jessamine Co. and married Sarah Hicks Dec. 21, 1852.

James Alcorn, son of James and Sarah Hicks Alcorn, was born in 1865 in Jessamine Co. and married Anna Eliza Corman, Dec. 18, 1886, in Jessamine Co. James Alcorn died Apr. 29, 1936, in Jessamine Co.

Garrett Alcorn, son of James and Anna Eliza Corman Alcorn, was born Apr. 10, 1902, in Jessamine Co. and married Vela Doris Morrow, Oct. 31, 1936. Garrett Alcorn was a farmer and fisherman. He died Oct. 27, 1988, and is buried in the Wilmore Cemetery. Vela Doris Morrow Alcorn was born Aug. 26, 1918, in Wayne County. She died Feb. 13, 1945, and is buried in the Mt. Hebron Church Cemetery in Garrard Co. Children of Garrett and Vela Doris Alcorn are Mildred and Renda Ann Alcorn.

Renda Ann Alcorn was born Feb. 18, 1942, in Boyle Co. Renda Ann married Carl Ray Puckett and they have two children: Frances and Carl Ray Puckett I r. Reudadied May 14, 1982 ad is leaved in the May le Erone Cometery

Sarah Margaret Land Alexander Family

Sarah Margaret (Land) Alexander was born 6/12/ 1913, in Fayette Co., near Valley View. She was the daughter of Edgar Poe Land (1/8/1879-1/5/1956) of Fayette Co., and Atha Margaret (Stafford) Land (10/ 10/1885-4/13/1966) of Jessamine Co. Her brother, Edgar Poe Land, Jr. (11/26/1916) lives on Union Mill Road in Jessamine County. As a child, Sarah Margaret was active in 4/H Club and in July, 1930, was awarded a scholarship to attend Camp Miniwanca, the American Youth Foundation Camp in Shelby, Michigan. For several summers she attended the camp as a camper and later as a counselor. Sarah Margaret graduated from Spears High School in Jessamine County on 5/ 14/1930 and received her B.A. degree in journalism from U.K. in June 1934. She taught at Red Oak School, Jessamine Co., 1934-35; Russell Cave School, Fayette Co., 1936-41; Lafayette High School, Lexington, 1942-43; and received her M.A. degree from U.K. in 1940.
