

Robert and Susannah Turpin Welch Alcorn:

Robert Alcorn, son of John and Jane Breckenridge Alcorn, was born between 1765/1775. Robert Alcorn married Susannah Turpin Welch, a widow, in Madison County, Kentucky 25 May 1796. A mistake was made by the clerk; when he wrote out the marriage bond for Robert and Susannah; the clerk put John and Susannah were to be married; when it should have been Robert and Susannah. That Robert and Susannah were married is later validated by Census Records showing Robert and Susannah Alcorn. John Alcorn, father of Robert, signed the bond and William Smith was a witness. Some researchers picked up on the William Smith as being the father of Susannah. This was not so; as there is a Madison County, Kentucky marriage bond for Susannah Turpin to Thomas Welch 9 Jan. 1794. Susannah and Robert sold land in 1796 in Madison County, Kentucky. The land was on Tates Creek ; that Susannah had received from her former husband (Deed Book D page 128). Robert and Susannah Alcorn were in Madison County, and then in Fayette County and ended up living in Gallatin County, Kentucky. Robert was on the 1820 Gallatin County Census and marriage records show his daughter Sally marrying in 1819 . Robert died 1825/30 in Gallatin County, Kentucky. Susannah Turpin was born 1777 in North Carolina . Susannah was living in 1850 in Gallatin County, Kentucky at age 73 with Mary Holbert and Mary's three children Artinisa age eleven., Harriett age five., and William age three.

Lucy Alcorn, daughter of Robert and Susannah Alcorn, was born before 1795 and would be a daughter of Susannah and Thomas Welch. She married under the name of Alcorn. Robert Alcorn signed permission for Lucy Alcorn to marry Moses Hicks 16 April 1811 in Fayette County, Kentucky. Moses Hicks was a son of William and Mary Swanger (Swango) Hicks.

Rebecca Alcorn, daughter of Robert and Susannah Alcorn, was born between 1795/1800 and married William Hicks 12 Jan. 1815 in Fayette County, Kentucky. William Hicks was the son of William and Mary Swanger (Swango) Hicks. William and Rebecca owned 2 and 1/2 acres of land in Jessamine County, Kentucky where his mother made her home. William and Rebecca lived in Fayette, Jessamine, Gallatin and Harrison Counties of Kentucky. William Hicks served in the war of 1812 and Rebecca filed pension papers (#4797) 10 Oct. 1872. Rebecca Alcorn died 17 July 1875. William Hicks was born 4 Dec. 1794. He enlisted in service 27 Aug. 1812 and served in Capt. John Wyatt's Co. . William was discharged 5 Nov. 1813. William Hicks died 12 March 1868. (Family descendant and researcher Audel H. Hicks)

Jesse Alcorn, son of Robert and Susannah Alcorn, was born ca. 1805 and married 16 April 1830 to Sarah Darbro. Jesse's second marriage was to Phoebe Darbro, widow of William Darbro 26 Oct. 1849
