That the Co-Administratrix state that in the processing of this estate they and their attorney were required to manage real estate, to work and supervise in the cleaning and preparing of personal property to achieve the highest sale thereof, that they confronted with exceedingly large claims against the estate for personal care totaling \$14,873, that they obtained a settlement thereof for \$2300 saving the estate 12,573.00, that they had to amend Federal and State tax returns, their lawyer traveling and caring for the same obtaining a return of monies to the estate of \$1676.56, that they had to create a family tree for the deceased running down both sides of her grand parents decedants at much time and expense in phone calls and travel and do various and other work not usual to an estate and should be compensated over and above the usual 5% fees of the gross estate for attorney fees and adminstratrix fees each; that they feel their work was twice the usual, though in an effort to further preserve the assets of said estate they have listed their fees 3 1/2% higher then the usual 5% each.
